Paperwork Requirements

Please send in your registration forms to Hilltop Farm as early as possible, as stabling and other services fill quickly. If presenting a stallion for licensing or mare for the MPT, additional registration forms must be sent directly to the ISR/Oldenburg registry and are available on their website. A few additional forms are required for horses incoming to Hilltop and will be sent to you upon your registration form being received.

ISR/Oldenburg registration fees are due on-site after the inspection and prior to the branding (if applicable). Please have a check payable to ISR/Oldenburg ready immediately following your horse's presentation. Payment for services rendered by Hilltop Farm is due separately and must be sent in with the attached Hilltop registration form.

Bring the following with you to the inspection:

Mares

- Original four generation pedigree
- Copy of pedigree

Foals

- Breeding certificate completed by stallion owner and signed by your vet
- If foal is not presented at the side of the mare, must provide DNA testing

\$50.00	Handling for the mare and foal together

**If braiding services are requested, please note you must arrive at least 1 1/2 hours prior to your scheduled presentation time.*
